It is reiterated, as per DoPT's instructions dated 4.4.2011, that failure to ensure timely submission of APR would result in denial of Vigilance Clearance for any purpose i.e. promotion, MACP, probation, confirmation, permission/NOC for going abroad/passport, applying in other deptts. etc. The non-submission of APR within prescribed time limit (1.1.2021 to 31.1.2021) will result in denial of vigilance clearance for any of the above or other purpose and cause deprival of the same for which the individual will be responsible.
