With reference to CHQ, Faridabad's Office Order No. 177 of 2019 issued under letter No. 10-6/2018-Sci.Estt-3930 dated 30.04.2019, it has been observed that the Scientific Officers who have been given in-situ promotion under this order are not mentioning the actual date of assumption of Charge in their CTC form. In this regard, concerned Regional Director/HOO/DDO are requested to co-operate and ensure that there are no cases of excess payment due to wrong pay fixation.
