- 6. Acceptance of Voluntary Retirement in respect of the Non-Gazetted officials upto the Pay Level 6
- 7. Appointment of AMAs for employees of CGWB, CHQ and field offices of the Board
- 8. Signature of Agreement Deed of building hired for field offices
- 9. Sanction emergency Medical Treatment Bills of CHQ and Field Offices
- 2. The above delegated powers will be exercised subject to the limitations/restrictions and scales mentioned in DFPR's 1978 read with GFRs 2047, FR & SRs and other relevant orders issued by the Government / Competent Authority from time to time and will remain in force till further orders.
