### OFFICE MEMORANDUM

Sub:- Handling of Court Cases by Regional Directors/Head of Offices and Nodal Officers - Observations- regarding

It is the duty of concerned Regional Director / HOO / (Nodal Officer, nominated by RD / HOO) to liaise with the Government Counsel, attend court hearing from time to time, get the latest status of the cases and keep the CHQ informed immediately. It is pertinent to note that court cases must be handled by responsible officers because these are being monitored on weekly basis by Hon'ble Minister (Jal Shakti), as intimated vide OM No.42017/24/2018-E-IV Section dated 12.06.2019 (copy attached).

However, over a period of time, it has been observed that RDs / HOOs and Nodal Officers are not paying adequate attention towards court cases and large No of cases are still pending in various courts. Summary of pending court cases is given in the Annexure attached.

It will be seen that in some stations No of courts cases is substantially high like Hyderabad - 20, Jaipur - 17, Lucknow-14, Bhubaneshswar - 12, Chandigarh - 08, Delhi - 08 and Chennai - 06.

In past following shortcomings have been observed, which need immediate action :-

- (a) Non- attendance of court case hearing resulting into NO timely feedback regarding next date of hearing and brief of arguments heard in the court.
- (b) Date of filing of reply is not intimated, which indicates lack of interest / liaison with Government Counsel.
- (c) There seems to be no briefing / interaction with Government Counsel which results in stay on DPCs, promotions and transfers etc.
- (d) At some places trend to file court cases is rampant, which is evident for summary of court cases.

In view of above, RDs / HOOs are requested to take personal interest and ensure that update on court cases is intimated immediately and shortcomings listed above are addressed on priority. This aspect assumes more importance in view of recent directions by the Hon'ble Minister.

This issues with the approval of the Chairman CGWB.
