Nonetheless, to dispel any misinformation, or misunderstanding, following points are highlighted:-

- (a) Only those officers / officials have been considered for transfer who have put in maximum permissible accumulated tenure at present station. (i.e 12 years/15 years/18 years as applicable).
- (b) RTP Committee / Approving Authority have endeavored to give one of the choice stations. However, in few cases, individuals have been transferred to other places in Organizational interests.
- (c) As far as possible, request for transfers have been accommodated.
- (d) In case of Group 'B' (Non-Gazetted) and Group 'C' officials, field staff like TOD, ADCM, DCM, ASK, TOS, TOM etc. have not been transferred based on accumulated tenure. In their case, only requests for transfers have been considered. However, few requests for transfers could not be met as maximum requests are for selected stations and may result in unequal distribution of manpower.
- (e) RTP committee members and Approving authorities have taken additional pains to consider and deliberate upon each and every case as per its merit.
