Please refer to CHQ letter under reference on the subject cited above. In this context, it is informed that representations received from various stakeholders regarding discrepancies in draft seniority llist of TOD as on 07.02.2018 have been examined in detail and reply to the points raised therein are as under:-

- The posts of TOD & Compressor Operator merged and designated as TOD and placed in the pre-revised pay scale of PB-1, Rs.5200-20200/- with Grade pay Rs.1900 vide CHQ office order No.455 of 2016 dated 11.08.2016 is in accordance with Ministry's letter No.23/01/2015-CGWB dated 27.07.2016 read with Department of Expenditure OM No.1-2/2016-IC dated 25.07.2016 & notification number GSR 721 (E).
- Since the posts of TOD and Compressor Operator have been merged and designatied as TOD vide CHQ office order No.455 of 2016 dated 11.08.2016, there can't be separate seniority list for these posts. The Recruitment Rules of TOD after merger have also been notified vide GSR No.243 dated 21.07.2017.
- 3. As mentioned in reply at point 2 above, Recruitment Rules of the merged post of Technical Operator (Drilling) have been notified vide GSR No.243 dated 21.07.2017.
- 4. The revised seniority list was prepared, keeping in view DOPT OM No.20020/4/2010-Estt(D) dated 13.09.2012 wide which where posts having different pay scales prior to 6<sup>th</sup> CPC recommendation and now after merger have come to lie in the same pay Band with same Grade Pay, the inter-se seniority of all the

employees will be fully maintained with employee in a higher pre-revised pay scales being placed higher vis-a-vis an employee in a lower pay scale. Therefore the draft seniority list of merged of TOD prepared by this office is in order.
