Sub: Willingness for filling up the post of Despatch Rider in CGWB, CHQ, Faridabad - regarding

Sir,

I am directed to invite a reference to Board's letter No. 17-19/2021-Min.Estt-2822 dated 15.07.2021 on the subject cited above vide which it was informed that the post of Despatch Rider is going to fall vacant on retirement of Sh. Jaspal Singh, Despatch Rider on 31.12.2021. Therefore, the process to fill-up this post at CGWB, CHQ, Faridabad from Multi Tasking Staff is to be initiated as per the eligibility criteria prescribed in RRs of Despatch Rider for promotion as mentioned below:-

"From Multi Tasking Staff, Group 'C' employees having three years regular service in the Central Ground Water Board subject to passing driving test based on the following syllabus:

- (i) Ability to read English numerals and figures.
- (ii) Basic knowledge of driving the motor cycle.
- (iii) Basic knowledge of maintenance and mechanism of motor cycle.
- (iv) Passing knowledge of maintenance of log book or history sheet of motor cycle.
- (v) Possessing knowledge of traffic rules.

Training:

"Two weeks, induction level, safety on road, Operation and maintenance of motor vehicles (Level-I) from Rajiv Gandhi National Ground Water Training and Research Institute, Raipur".

But, so far no application from any MTS is received in this office. Therefore, all the Heads of Offices of CGWB / CGWA/ RGI are once again requested to bring the above contents into the notice of all MTS and forward the applications of willing and eligible MTS in the enclosed Application Form well in advance so as to reach CGWB, CHQ, Faridabad on or before 12.10.2021. No application received in CHQ after 12.10.2021 shall be entertained under any circumstances including any pretext whatsoever.
