Sir,

Please refer to CHQ's previous letters of even dated 09.11.2020, 01.02.2021, 15.06.2021 and 29.06.2021 (uploaded on website) on the subject cite above. In this connection, it is to inform that in order to process compassionate appointment for the Year 2019, all the Head of Offices were requested vide this Office letter No.17-01/2020-Min.Estt.-4034 dated 09.11.2020 to expedite application for compassionate appointment. The cut off date for submission of application was 31.12.2020.

But, it is observed that the field offices have not forwarded the details of family pension, monthly income, value of movable/immovable property, number of dependents, number of unmarried daughter and number of minor children as on

01.0.1.2019. Therefore, all the offices are again requested to get complete above information from the applicants in Annexure – 1, and send to this office duly signed and verified by concerned HOO vide this office letter of even No. dated 1.2.2021.

But, no information received from field offices duly completed. Therefore, once again all the Heads of offices were requested vide this office letter of even No. dated 15.6.2021 to get the above information as on 01.01.2019, 01.01.2020 and 01.01.2021 completed by the candidates in Annexure -1, verify and send to this office by 14.07.2021.

But, so far information duly completed in all respect in Annexure – 1 is received in respect of only 17 candidates from field offices which is mentioned in List – A.

In spite of several reminders to field offices, the information in Ann.1 in respect of nearly 101 candidates mentioned in List – B has not been received from the concerned offices which is seriously viewed not only by CHQ but also Ministry.

Therefore, once again, all the Heads of offices are requested to refer Ministry of Jal Shakti, New Delhi's OM No. 20/55/2005-admn. dated 28.02.2019 (Copy enclosed), appoint Welfare Officer, direct him to visit the family who have applied on compassionate ground, get the information completed in Annexure – 1 correctly, get verify and signed by Head of Office and send to this office latest by **09.08.2021** positively failing which the name of the candidates will not be considered for appointment on compassionate ground and concerned Head of Offices will be held responsible for the same.

It is therefore requested to send this information at the earliest, latest by 09.08.2021. If any applicant has not submitted the information on time, Welfare Officer or any other Officer/Official of your office may be deputed to help the candidate/family to provide the information. Ministry has given timeline to complete the compassionate appointment in a limited timeframe.

All offices are requested to co-operate in our endeavour to give compassionate appointment to deserving candidates as early as possible.
