Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

4. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product

during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. 5. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 7. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. # 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

#### 2. Sample Clause

For clothing and allied items, if pre-dispatch Inspection clause has been selected in the Bid, the Inspection Agency shall forward sample from the accepted lot duly identified/ sealed by it, as Reference Sample to each consignee (one reference sample per consignee) for comparing the lot received at consignee end with such reference sample. Such reference samples will be treated as part of supplied quantity from the lot and cost shall be borne by the Buyer.

#### 3. Forms of EMD and PBG

# Disclaimer

#### (I) DETAILED SPECIFICATIONS FOR SHOULDARY DOUBLE FLY WATER REPELLENT TENT (3.66 M X 3.66 M)

#### GENERAL:-

The quality of material used in the manufacture or supplied with the tent, the method of manufacture of components, the workmanship and making etc., shall be in accordance with D.G.S. & D specification No: G/Tex/T-1 read with D.G.S.& D Drg No.22624(Annexure-I) and shall be binding on the contractor. Leading dimensions are shown in the Schedule 'A'.

#### DETAILED DESCRIPTION:

Tents shall be double fly. It shall consist of an outer fly with hoods and an inner fly provided with overlapping purdahs at each end and walls.

OUTER FLY: The outer fly shall be composed of 2 folds of cloth in the following order :-

- (a) On the exterior [Polyester + Viscose(90:10)-410gsm] or Polyester +Viscose (67:33)-410 gsm with minimum breaking load wrap 2500N and weft:1800N
- (b) Drill cotton dyed Blue inside with minimum of 255 gram per square meter and having minimum breaking strength of 1075 N (Wrap) and 625 N(Weft).

It will have a hood at each end. The size of hood will be 0.76M X 1M. The edges of the hoods shall be strengthened with 50mm Newar placed between folds of cloths. It shall be broader by 0.6M at the bottom edge than the inner fly. It shall be 0.45M above the ground level. It shall be provided with Guy ropes. The Guy ropes at the ends will pass through the point of each hood, one end spliced round the cap and the other end passing through the point of each hood.

INNER FLY: The inner fly shall be composed of 2 folds of cloth in the following order:

- (a) On the exterior [Polyester + Viscose(90:10)-410gsm] or Polyester +Viscose (67:33)-410 gsm with minimum breaking load wrap 2500N and weft:1800N
- b). Drill cotton dyed yellow (printed) inside.

<u>NB</u> : The face side of Drill cotton used in both the layers shall be visible from outside i.e. the back sides of the drill cotton in both the layers shall face each other.

 Both the flies shall be strengthened with 50mm Newar and 19/20mm cotton rope piping. The rope piping shall be enclosed by an extra Newar 50mm. For construction see clause 21 of DGS&D specification No.G/Tex/T-1.

2. (a) Ridge of outer fly : Ridge of outer fly : A strip of 65mm or higher 75mm Newar with 25mm cotton rope laid above it shall be inserted between Polyester + Viscose(90:10)-410 gsm or Polyester + Cotton(67:33)-410 gsm and blue drill connecting two ridges caps. The side edges of Newar shall be stitched to the folds of cloth and the newar and rope shall be well within the ridge cap and secured by quilting. The rope shall form a loop round the cap and secured tightly.

Ridge of the inner fly : Ridge of the inner fly : The ridge of inner fly shall be formed by inserting a strip of 75mm or higher 100mm Newar between the folds of Polyester + Viscose(90:10)-410 gsm or Polyester +

Cotton(67:33)-410 gsm with 25mm diameter cotton rope so laid on the underside of the ridge and over the middle tape between the caps that the cloth of the fly and centre strip of Newar shall be doubled over the rope and sewn together with 3mm line cotton to form a beading. Loops made of 2 folds of 50mm Newar shall be stitched to the ridge for suspending it from the ridge pole. The rope shall form a loop round the cap and secured tightly.

- 3. Walls of inner fly: The inside layer of the walls shall be in continuation of the fly. Aluminium dees shall be provided at the bottom of walls and purdahs on each strengthening Newar. All corners should be kept open and provided with eyelets and lacing loops to close or open as required. Also see clause 25 of DGS&D Specification No. G/Tex/T-1 for construction.

- 5. (a) Fitting : A 50mm Newar shall be sewn over the folds of cloth at the bottom edges of the walls and purdahs of the inner fly so that the cloth do not make direct contact with the ground when pitched.
  - (b) Ventilators : The inner fly should be provided with 2 ventilators 45cm X 30cm, with the square mesh mosquito netting Bleached and two vertical and one horizontal Newar 40mm, machine stitched on the netting. The ventilators should be positioned on the either side of the central strengthening tape at equal distances.
  - Stitching: Minimum two layers of stitching should be given using cotton sewing tread 16 Tex/6 Tex or higher thickness complying to IS:1720, having minimum breaking load of 22.1N (2.25 Kgf) Min The 50mm cotton newar should have 25 grams per meter and minimum breaking load of 1420 N The 65mm cotton newar should have 31 grams per meter and minimum breaking load of 1770 N The 75mm cotton Newar should have 37 grams per meter and minimum breaking load of 2126N The 100mm cotton Newar should have 50 grams per meter and minimum breaking load of 2830N



For dimensions and other important requirements Director of Quality Assurance (DGS&D) Provisional Specification No-DQA/Delhi/Tex/Tents/1 (Shouldaries Double Fly Water Repellent) has been referred.
